Types of packages available for Board and Train: 1 Week (7 days) - \$1,600, 2 Weeks (14 days) - \$2,400, 3 Weeks (21 days) - \$3,200. All training packages include a 1-hour transfer lesson at pickup.

Rate: \$200 per week day (Mon-Fri), \$300 per weekends (Sat-Sun). Additional fee may be charged for special needs dogs or special circumstances (holidays, for instance) but will be disclosed prior to invoicing. Additional refresher lessons will be done in person with the owner present, in the form of a 30 min private lesson at the rate of \$45/session.

Your dog will receive a <u>minimum</u> of 60 minutes of dedicated training per day, passive training (the "living with the dog trainer effect" throughout the day), mental enrichment, playtime, socialization outings/field trips, age-appropriate exercise and lots of cuddles.

## **Liability Waiver & Policies**

If turned over to boarding or kept on site, any additional costs must be paid to Tay's K9 Management before dog will be released.
